Dear Fellow Lake Bluff Residents:

On behalf of my fellow trustees, we are pleased to offer you the 2014 Annual Report from the Friends of Lake Bluff Parks ("Friends"). The report plus additional supporting information can be found online at www.friendsoflbparks.org.

Highlights from 2014:

- As of year end December 31, 2014, the balance in the Friends Unrestricted Fund was \$34,579, an increase of \$15,649 from \$18,930 at December 31, 2013. The largest components contributing to the increase in funds were net proceeds from the Block Party and the Luau! and individual unrestricted donations. Consolidated funds at year end 2014 totaled \$90,902, including \$43,418 in the Paddle & Tennis Fund and a total of \$12,905 in other restricted funds designated for programs and assets such as the Golf Course and the Health and Fitness Center.
- The current balance of over \$34,500 in the Unrestricted Fund is over two-thirds of the way to
 achieving a goal of \$50,000 that the Friends expect to contribute to the Park District's cost of
 updating restrooms and stairs at Sunrise Beach. The Friends expect to reach the \$50,000 by
 year end 2015 based on estimates of total net proceeds from fundraising activities planned
 for the year.
- For the second year, the Friends sponsored, underwrote and co-produced the 2014 Lake Bluff Block Party held in July in conjunction with the Northwestern Medicine Criterium bicycle races. The Friends netted over \$10,000. Revenue was generated from corporate sponsorships, an Adirondack chair silent auction, a bike raffle and beverage sales. An estimated 3,000 people enjoyed the bike races, live stage performances from five local bands, food and beverages from several area restaurants and other activities.

- The Friends produced and hosted the Luau! at Sunrise Beach in mid-September. Guests dined on roast pig and danced to the live music of local band See Alice. The event generated net proceeds of over \$4,000 from ticket sales and a duck race raffle.
- In April management of the Noodles & Co. opening on Waukegan Road and Rockland Road chose the Friends as the exclusive not-for-profit distributor of opening evening discount meal coupons. Coupon sales proceeds of over \$1,500 were realized by the Friends.
- The passage of the \$3.1 million bond referendum in November and the awarding this past January of a \$400,000 Open Space Land Acquisition and Development (OSLAD) grant from the State of Illinois for the Park District's repair of the aquatic facilities were very welcome news for the Friends trustees. Though direct measurement isn't possible, we hope that producing activities such as the Block Party and the Luau! help increase community awareness of Park District programs and assets well deserving of community support.
- The Friends wish to give many thanks to four trustees who ended their terms in 2014. Jack Sheppard was an original trustee, serving since the founding of the Friends in 2005. Jim Salanty joined the Friends board in 2008. Alan Sidman made valuable contributions to financial policies and procedures as treasurer. Doug Warren took the lead in developing the web site and executing direct mailing campaigns as part of the branding and marketing effort. Thank you for your service Jack, Jim, Alan and Doug.
- The Friends welcomed new trustees Jacob Armstrong and Brad Adams, who joined in early 2014, and Betsie Sassen, who joined near year end. Brad has stepped in as treasurer and Betsie will serve as secretary in 2015. We look forward to their contributions to fundraising and energetic support for the Park District's programs and assets.
- The Friends trustees continued to work effectively with Park District staff and the Park District
 commissioners. Park District Executive Director Ron Salski and Park District Board
 Commissioner Susan Ehrhard serve as voting members of the Friends board. We couldn't
 have produced the Block Party and the Luau! without the energy and enthusiasm of the full
 Park District staff.

Looking forward:

- The Friends again will be sponsoring and co-producing the 2015 Lake Bluff Criterium and Block Party on Saturday, July 25th.
- A Luau! dinner party and dance bigger and better is planned for Saturday, September 12th.

- We expect to launch a targeted direct solicitation campaign in the early spring in which donors will be invited to "own a piece of the action" in the refurbished stairs at Sunrise Beach.
- We will continue to refine the Friends marketing and brand awareness activities. Some efforts have worked out well; some not so much. Our overarching objective is to help create a foundation to serve as an effective fundraising vehicle with long term sustainability.
- The Friends continue to cultivate community members interested in supporting Lake Bluff Park District by serving as trustee or as non-trustee leaders. The Friends website "About Us" tab has a link to further information and an application form. Or please contact one of the trustees or a Park District staff member.
