Community wide survey results were presented by Ron Vine (Leisure Vision). Board members were given detailed results and the community was able to ask questions during and after the presentation. Sections of the survey results and the presentation video will be posted on the Park District website for the community to view. The parks and recreations facility that the highest percentage of households have a need for

is the beach. The beach was rated as the most important facility and a high percentage of households indicated their willingness to use Park District tax dollars to improve the existing beach. Residents in attendance were concerned with the following: the accuracy of the survey and the correlation to neighborhoods who responded, parking if the beach were to be improved, and the upkeep of a bluff beautification project undertaken at the beach several years ago by the Lake Bluff Garden Club and the Park District.

Director Salski asked Mr. Vine's recommendation on how to proceed with these results. Mr. Vine indicated prioritizing what the Park District can accomplish in the next year, the next 5 years and into the future. Director Salski stated that the survey results are all taken into consideration for the comprehensive master plan of the Park District.
