A. 2010 Budget

Tax Levy

Director Peterson discussed the tax levy process, debt structure and fund balances.

Executive Director Salski and staff reviewed the following information:

2010 Proposed Budget Summary

For all funds, total budgeted revenues are expected to be \$5,315,500.

Operating expenditures for all funds are expected to be \$4,290,700.

Highlights of 2010 Proposed Budget

- No price increases
- Participation Numbers budgeted similarly as 2009

Capital Project and/or Equipment Replacement

In 2009, Capital was \$535,100 and in 2010, Capital is proposed at \$45,000.

Capital Replacement

Executive Director Salski provided a detailed spreadsheet to Commissioners. He mentioned this allows Commissioners to better understand the capital expenditures. Andy Thurman explained the challenges with the aging fitness equipment. Commissioners requested spreading the replacement costs over three years.

Program and Membership Prices

Staff proposed a 0% program and membership increase with one small exception related to a nine hole rate. A single golf rate will be implemented in 2010 allowing a blended resident and non-resident rate.

Golf Operations

Assistant Golf Operations Manager Heiser mentioned the single rate eliminates the penalty for non-residents and encourages individuals to play more often at Lake Bluff. Commissioners agreed with this policy.
