#### 6. ITEMS FOR DISCUSSION

A. Facility Pricing & Reservations

At the November 3, 2010 meeting the Committee recommended amending the Administrative Policy Section 7.4 (Recreation Facility Rental Use Policy) to read as follows:

<u>Defined Guests</u> <u>Fees</u>

1. Residents Resident Rate

Affiliates Resident rate less 50%
 Facility Membership Resident rate less 35%
 Community Organizations Resident rate less 25%
 Non-residents Resident rate plus 40%

After a lengthy discussion today, the Committee recommends amending the policy for Beach shelter rentals only to read:

<u>Defined Guests</u> <u>Fees</u>

1. Residents Resident Rate (\$35)

Affiliates
 Facility Membership
 Non-residents
 Resident rate less 50% (\$17.50)
 Resident rate less 35% (\$22.75)
 Resident rate plus 40% (\$56)

Examples of proposed changes:

Yacht Club:  $(5 \times $100) - 50\% = $250$ Community Church:  $(15 \times $50) - 25\% = $562.50$ Grace Methodist Church:  $(1 \times $50) - 25\% = $37.50$ Lake Bluff Open Lands:  $(1 \times $100) - 50\% = $50$
