Members asked questions. Member Falligant and Danly stated the time to move forward even when there are differences.

Member Terrill received consensus from the Committee. Member Terrill allowed residents to ask questions to Michelle Kelly and Advisory Committee. Larry McCotter had concerns with the steps at Mountain Avenue. Karen Crotty had concerns with the steps at Mountain Avenue because she was concerned with the Bluff. Perry Walcott had concerns with the steps at Mountain Avenue because he was concerned with the plantings and extensive engineering. He had a question about the type of lighting proposed. Nan Wick had a question about using a rubber mat for accessibility. Al Trefts had concerns with the stairs at Mountain Avenue with the amount of steps and dog owners and dogs going up and down. He suggested a north access door on the storage building. Bo Harper suggested evaluating use of solar/wind components. He suggested putting a vista on top of the shelter. Carol Russ suggested short term rehabilitation and renourishment with a good first phase.

Members made comments and requested adding specific items to the Waterfront Concept Plan:

Stairs to dog beach Vending Steps to water near South Beach More natural approach with lookout area south of north shelter Showers on North and South end North access to storage building
