#### NEW BUSINESS-BOARD AND STAFF WORKSHOP

Lake Bluff Golf Club – Equipment Loan – Lake Forest Bank and Trust – Principal Amount \$182,245.68 – Approval

Executive Director Salski explained the loan agreement and terms for the purchase of 40 used golf carts and repair/refurbish 20 existing golf carts. He stated the loan was for five years at 4.75% with no pre-payment penalty. He stated that the attached loan agreement is an annual term but a monthly term would save the Park District \$4,000. Based on conversations with Commissioner Mosbarger and Treasurer Wallace, Executive Director Salski recommended signing a monthly term.

Executive Director Salski requested action to authorize the Executive Director and/or Board President to enter into a five-year equipment loan with Lake Forest Bank and Trust for a principal amount, \$182,245.68, 4.75% interest and monthly payments to purchase 40 used golf carts from Nadler Golf Car Sales, Inc. and repair/refurbish 20 golf carts from Harris Golf Carts.
